Account verification

Open the prototype

The Account Verification Journey allows you to verify new users quickly and accurately through bank-grade security checks without having to process streams of raw data.


Your customer starts their verification journey through your app.


Step 2


Step 2


Once they've selected a bank account to transfer funds from they can review the payment.

Step 1

Prompt your customers with a notification that takes them straight to the app to start the top-up journey

Step 2

To fund the account your customer chooses their bank. Bud covers 96.5% of current accounts in the UK


Step 3


